## Contents

This list supersedes the list issued in May 2010. The four Inn libraries are open to any barrister.

The list covers all law reports and periodicals (including the daily newspapers) *currently received* by one or more of the four libraries. Older reports and periodicals that are no longer taken or that have ceased publication are not included. Digests and indexes of cases otherwise reported are not included, nor are monographic series and legislation.

The list only includes those law reports and periodicals held by the libraries in print format. All the libraries also have access to numerous electronic serials, most notably through subscriptions to **Lexis Library** and **Westlaw UK**. In addition, Lincoln's Inn and Middle Temple have subscriptions to **HeinOnline**, which has back runs of a large number of academic journals, mainly American law reviews but also English, Commonwealth and international titles.

The list is arranged alphabetically by title. Where there has been a change of title, entry is by latest title. Holdings are complete where the Library abbreviation stands alone.
