





Black History Month 2017

To celebrate Black History Month this year we have profiled some influential and inspiring members of the Inns of Court. The profiles are on display around the Library for the remainder of the month.








Tours and Visitors

AccessToLaw: Europe

With Brexit negotiations currently a topic of great public interest and discussion, this seems an appropriate moment to review the contents of the **Europe** section of our **AccessToLaw** gateway site. We have done so before, but that was ten years ago, in the issue of October 2007. There are currently over 40 entries, most of them concerned with the European Union, and a few providing information on the Council of Europe.

The main Council of Europe site provides a starting point for all CoE information, with links to the web pages of its many institutions, secretariats, directorates and activities. We also provide direct links to two particularly important sections of the site - Council of Europe: Committee of Ministers and Council of Europe: Treaty Office - and to the separate site of the European Court of Human Rights. Treaty texts are complete back to 1949, and ECHR cases also back to the court's establishment in 1959.

Europa: Official Website of the European Union is a comprehensive portal site for official information on all areas of EU activity, including its membership, history, institutions, laws and publications. Its "EU Law" section provides access to case law, legislation, treaties and other legal documents.

We also provide a direct link to Europa: Official Documents, a page within the vast and complex Europa site which brings together in one place links to official documents of the EU bodies and institutions which are spread around many sections of the site, some of them concealed within the Official Journal.

A separate site, managed by the EU's Publications Office and updated daily, is devoted specifically to EU law: EUR-Lex. It incorporates the EU's CELEX database and includes legislation in force, case law, the Official Journal, treaties, preparatory acts, and information on national implementation.

Other official sites include those of the main EU bodies and institutions, most notably the European Commission, the European Parliament, and the Court of Justice of the European Union. There are also entries for some of the EU's specialised sections and agencies, such as EU Law and Publications (website of the Publications Office) and the European Union Agency for Fundamental Rights.


Besides these and other official sources, there are entries for several useful websites which are maintained by various academic institutions, professional bodies and other organisations. To take just two examples:

Dec.Nat - National Decisions is a database containing over 29,000 references to national decisions concerning EU law from 1959 onwards, produced by the Association of the Councils of State and Supreme Administrative Jurisdictions of the European Union; and European Union: A Guide to Tracing Working Documents, published on New York University's GlobaLex site, gives guidance on finding travaux préparatoires from the various institutions of the EU.

The sites so far described are almost entirely concerned either with the Council of Europe or the European Union, but the European Database of Asylum Law, managed by the European Council on Refugees and Exiles, is one which covers case law of both the European Court of Justice and the European Court of Human Rights, and of many EU member states.


Most of the entries in AccessToLaw's Europe section are for long-established websites, so almost all were probably present back in 2007. Two at least though are certainly new. Department for Exiting the European Union is a section of the GOV.UK website where the Government's Brexit position papers and other publications may be accessed, and Department for Exiting the European Union: European Memoranda is a web page produced by the Cabinet Office which provides links to Government Explanatory Memoranda on EU documents submitted to Parliament April 2012 onwards, to related EU documents, and to information about parliamentary scrutiny of EU documents.

New Acquisitions




Successive judgments of the Court of Appeal have reinforced the message that advocates and judges have a duty to ensure vulnerable witnesses and defendants are treated fairly and allowed to participate effectively in the process. Vulnerable people and the criminal justice system (Oxford) by Penny Cooper and Heather Norton aims to

provide practical guidance on recognising, assessing and responding to vulnerability in witnesses and defendants at each stage of the criminal process. The authors address such questions as: how do practitioners recognise who is or may be vulnerable?; what account should police and the CPS take of a defendant's vulnerabilities?; how should advocates adjust their questioning of vulnerable witnesses and defendants while still complying with their duties to their client?; and how should judges manage a trial to ensure the effective participation of vulnerable witnesses and defendants?



The law faces great challenges in keeping up with the rapid development of technology providing opportunities for the misuse of computers for commercial gain or other reasons. Cyber security law and practice (LexisNexis) by Dean Armstrong QC, Dan Hyde and Sam Thomas covers the law, both civil and criminal, applicable to data control, data management


and cyber issues. It considers the legal implications of internal threats from employees, data mismanagement or inadequate software, together with external threats from competitors or criminals, and examines practical ways to deal with potential or actual cyber incidents.



Andrew Simpson and Adelyn Wilson, authors of volume one of *Scottish legal history* (Edinburgh University Press) make honourable mention of two earlier works in the same field, both of which we hold (as is appropriate since we have a special responsibility for Scots law among the Inn Libraries), while noting that an update was needed to

take account of current scholarship. This first volume covers the medieval and early modern period, from 1000 to the union with England in 1707.

The rolling update of *Halsbury's laws of Canada* has ensured that all the constituent titles have been reissued at least once (in some cases several times) since publication began in 2006. Recently published volumes cover Athletics, Aviation and Space, Bankruptcy and insolvency, Landlord and tenant, Limitation of actions, Medicine and health, Personal property and Receivers.





Rare Book Corner

About a month ago, in what must be a first for this Library, we received a visit from an historian of dance. This was to examine our copy of John Playford's The Dancing master, or directions for dancing country dances, 4th edition, 1670. Playford, as well as a musician and a printer, was both the compiler and (in today's terms) publisher of this collection of tunes and instructions for dancers. He became a tenant of the Inner Temple when he established his shop by the entrance to the Temple Church sometime between 1642 and 1646; appropriately one of the dances is called "Pegasus, or the Winged Horse". Although the Dancing Master must have been a mass-market item in its day, surprisingly few copies are traceable in libraries; Wing's Short-title catalogue (which admittedly does not purport to be a thoroughgoing census of copies) mentions only two locations for this edition. Doubtless the book was for the most part acquired by private households and only found its way into libraries indirectly. This copy belonged to F.A. Inderwick QC (Treasurer in 1898), whose bookplate it bears. Inderwick was responsible for the first three volumes of the Calendar of the Inner Temple Records, wherein Playford is described as "a puritan, but not of an ascetic character".
