

Lexis: New Platform

As those who visit the Library regularly may have noticed, access to LexisNexis online services is now via the new platform, Lexis+ ('Lexis Plus').



All the same content is available as before: law reports, legislation, journals, books and practical guidance, but it is arranged differently. Lexis have put together some useful <u>video introductions to</u> <u>the new interface</u>. Alternatively, you can just ask a member of staff.

Database Training Sessions for New Students

The Library has arranged training sessions on Lexis+ and Westlaw. These will be run virtually by trainers from Lexis and Thomson Reuters.

Advantages of attending:

- Knowing how to navigate the databases quickly and easily is a key legal research skill
- Learning good techniques for searching will save you time
- Learning these skills now will build your confidence for starting pupillage

Qualifying Sessions on Legal Research - What to Expect

Library staff have been running qualifying sessions on legal research for many years. The sessions in the autumn are aimed at refreshing some of the basics of legal research that may have been forgotten. Tracey and Simon will present the sessions, which are based on questions that users regularly ask us at the Enquiry Desk; our experience tells us that a refresher is no bad thing when you are feeling under pressure to find something. We will make use of Slido to engage our audience and there will be plenty of opportunities to ask questions as we go along.

In early 2024 there will be another, more advanced session that builds on what we cover in the autumn. We will follow this up in the spring with a training session aimed at new pupils. So if you do not manage to attend all the qualifying sessions on legal research, the pupils' session will help you as you embark on the next stage of your career.

Inns of Court Libraries' Talk to New Bar Students

On 14 September the Deputy Librarian and one of the Assistant Librarians at the Middle Temple visited the University of Law campus in Bloomsbury to give their new Bar students an introduction to the libraries of the Inns of Court. The following day I and the same member of staff from the Middle Temple visited the recently opened City Law School building in Farringdon, likewise to introduce their new students to the libraries.

The aim of the talk we gave is to dispel any myths and preconceptions that new students may have about the Inns of Court libraries, so that (we hope) they feel comfortable visiting and using the libraries early in their legal careers.

We highlight the depth of the collections that are available to new student members of an Inn of Court, and stress how this will be important for them as they progress in their careers at the Bar.

We also encourage students to attend the various training events held by the four libraries, and to utilise the learning resources available to them.

Both sessions were well attended, and we have had several student attendees already visiting the Library.






New Acquisitions



Kevin Kwok-yin Cheng's The Timing of Guilty Pleas: Lessons from Common Law Jurisdictions (Cambridge University Press) offers a comprehensive investigation of how the timing of guilty pleas affects various facets of the criminal process, from the factors that affect this


timing, to the effects that the sliding scale of sentence discounts has on sentences and on public opinion about them. It draws comparisons chiefly between the England & Wales and Hong Kong legal systems, although the sentencing regimes in place in Australia, New Zealand and Scotland are also discussed.



Financial Crimes in Canada: An Overview of Money Laundering and Fraud by Margot Davis, Jennifer Lynch and Melanie Russell (LexisNexis Canada) covers a broad range of topics, such as occupational fraud, social assistance fraud, and fraud in the context of

family law disputes. The volume also includes a chapter on the challenges inherent in the civil and criminal litigation of fraud, with commentary from counsel who practise in these areas. In addition, the authors examine money laundering, including the history of the relevant sections of the Criminal Code, and the obligations of reporting entities under the Proceeds of Crime (Money Laundering) and Terrorist Financing Act.

To continue with the Commonwealth connection. there are new editions on various topics in the ongoing revision of Halsbury's Laws of Canada. The latest volumes received cover Compensation and rights of crime victims, Competition and foreign investment, Condominiums, Employment, Income tax (international), Workplace health & safety, and Youth justice. We have also recently acquired new editions of two classics of Indian legal literature: Jain's Indian Constitutional Law and Pollock & Mulla's The Indian Contract Act 1872.



Diverse voices in public law, edited by Se-shauna Wheatle and Elizabeth O'Loughlin, was purchased under the Library's Patron-**Driven Acquisitions** Scheme. This is a title in **Bristol University Press's** Diverse Voices series and,

breaking platform for critiquing the law from the perspective of minoritized and marginalized groups, and debating and understanding the impact of the law on these different groups.

Databases at the Inner Temple

The Library subscribes to a full range of legal subscription databases.

Knowing what each database contains and what its USP is will make your research easier. Conversely, looking for something on the wrong database is frustrating and wastes time. Below are a few key points that you might not know about:

Westlaw

- Contains the online version of Kemp and Kemp, the White Book, Archbold Criminal Pleading Evidence & Practice and Chitty on Contracts
- Consolidated legislation UK Acts and SIs
- Index of legal terms incorporating Stroud's Judicial Dictionary and Jowitt's Dictionary of English Law
- Legal journals Index for full text articles and abstracts back to the mid-1980s
- Full text of a range of law reports and transcripts

Lexis+

- Contains the online version of Blackstone's Criminal Practice, Stone's Justices' Manual and Cook on Costs
- Consolidated legislation UK Acts and SIs
- Words & Phrases Judicially Considered
- Online version of Atkin's Court Forms and the Encyclopaedia of Forms & Precedents
- Database of international materials
- Full text of a range of law reports and transcripts

- The most comprehensive database of Court of Appeal transcripts
- Some specialist law report series such as Immigration Appeal Reports and Mental Health Law Reports
- UK Acts and subsidiary legislation as originally enacted
- Bermuda Law Reports and BVI cases as well as a huge collection of Caribbean case law
