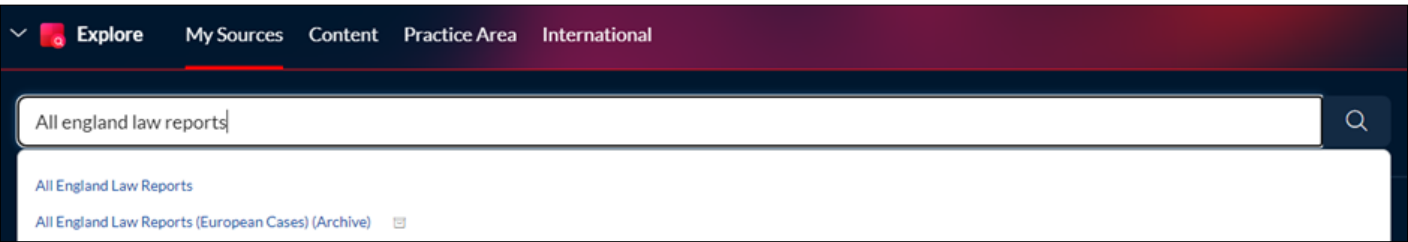
Home Page

In the main search box you can enter your search terms.
